# ISO 22301 Business Continuity Management System

**ISO 22301**, the world's first international standard for Business Continuity Management (BCM), has been developed to help Organizations minimize the risk of such disruptions.

ISO has officially launched an update version of **ISO 22301**, "Societal security - Business continuity management systems – Requirements", the new international Standard for Business Continuity Management System (BCMS).

ISO 22301:2012, "Societal security -- Business continuity management systems --- Requirements", specifies a management system to manage an organization's business continuity arrangements.

**\$0 22313:2012** does notenforce uniformity in the structure of a BCMS, but guides an organization to design a BCMS



# **Build ISO 22301 Competencies:**


The decision to implement a business continuity management System based on **ISO 22301** is often a very simple one, as its benefits speak for itself. Most companies now realize that it is not sufficient to implement a generic, "one size fits all" business continuity plan. To effectively maintain operational continuity, such a plan must be customized to specific risks and catastrophic scenarios which could range from major building loss to local system failure. A more difficult task is the compilation of an implementation plan, which balances the requirements of the standard, the business needs and the deadline for certification.

# **Setting up the Organization for ISO 22301 compliance and certification:**

- Implementation of the management system: Before being audited, a management system must be in operation for a minimum period of 3 months.
- Internal audit and review by top management: Before a management system can be certified, it must have had atleast one internal audit report and one management review.
- **Selection of the certification body (registrar):** Each organization can select the certification body (registrar) of its choice.
- **Pre-assessment Audit (optional):** An organization can choose to do a pre-audit assessment to identify any possible gap between Its current management system and the requirements of the standard.
- **Stage 1 ofAudit:** A conformity review of the design of the management system is done to verify that it is designed to meet the requirements of the standard(s) and the objectives of the organization. It is recommended that at least some portion of the Stage 1 audit be performed on-site at the organization's premises.
- Stage 2 of Audit (On-site visit): The declared management system is audited to ensure it (a) conforms to all requirements of the standard, (b) is actually being implemented in the organization and (c) can support the Organization in achieving its objectives. Stage 2 takes place at the site(s) of the organization's sites(s) where the management system is implemented.
- Follow-up audit (optional): If the auditee has non-conformities it requires an additional audit before being certified. The Auditor will perform a follow-up to validate only the action plans linked to the non-conformities.
- **Confirmation of registration:** If the organization is compliant with the conditions of the standard, the Registrar confirms the registration and publishes the certificate.
- **Continual improvement and surveillance audits:** Once an organization is registered, surveillance activities are conducted by the Certification Body to ensure that the management system still complies with the standard. The surveillance activities must include on-site visits that verify conformity of the certified client's management system and may also include: investigations following a complaint, review of a website, a written request for follow-up, etc.
