 no ISO 14001 requirements.
- Focuses on hazards and risks.
- Requires no periodic surveillance recertification every three years.
- Focuses on the headquarter site, with incremental inclusion of production sites.
- May be valuable for organizations with only domestic manufacturing and supply chain activities.
